Advance Care Planning documentation is underutilized. Hospital staff report that ACP documentation is hidden, inconsistent, or invalid. It can also reduce hospital admissions, ICU utilization, and hospital deaths, while increasing hospice use.

There are insufficient institutional resources to properly engage vulnerable patients. When signers can complete documents with patients using mobile signature technology, it streamlines the process for busy clinicians.

Nancy now Chairs the EOLONM Clinical Outreach and Education Committee as well as serving as the Clinical Outreach and Client Services Advisor to the Board of Directors

Debbie Armstrong

Debbie Armstrong served four terms as the State Representative for House District 17 (Bernalillo County) from 2015 – 2022. Among the bills she sponsored in the NM Legislature were the 2017 End-of-Life Options Acts (HB 171), the 2019 (HB 90) and the 2021 (HB 47) Elizabeth Whitefield End-of-Life Options Act. She successfully shepherded the 2021 legislation through the House and on to final approval in the Senate. Debbie serves as President of Delta Management Group, Inc. a small business specializing in association and non-profit management. In that capacity, she serves as Executive Director of the New Mexico Medical Insurance Pool, a legislatively created safety-net program that provides subsidized health insurance for people with high-risk medical conditions. Debbie has a B.S. in Physical Therapy from the University of Michigan and received her J.D. from the University of New Mexico Law School. On a personal note, Debbie has an adult daughter with childhood-onset metastatic thyroid cancer, an experience that has linked her to families across the state struggling with serious, life-threatening medical concerns. She hopes to bring not only her personal and professional experience with death and dying but also her long history of relationships with the medical community, state government and the legislature to her service with EOLONM.

Julia Bergen M.Ed.

Julia is excited to be joining the EOLONM team to increase awareness and understanding about individuals' options and choices regarding end of life – essential and practical steps leading to peace of mind for individuals, families and loved ones. With over twenty years of experience as a leader of regional New Mexico education/social justice organizations, Julia brings a wealth of knowledge and expertise to EOLONM. A seasoned fundraiser, Julia has raised more than \$20 million during the course of her career creating robust public/private revenue strategies designed to sustain the social change work about which she is passionate. A highly motivated and compassionate leader, she has built an impressive skill set that includes strategic planning, marketing and communications, program management, staff development, grant writing and fundraising. Julia holds a Masters in Education from the Harvard Graduate School of Education and a Bachelor of Arts in Literature and Art History from SUNY's Purchase College.

Sherry Burns

After retiring as a director for a medical software company, Sherry was inspired by the growing shift in Western culture towards reclaiming ownership of the death journey and became an end-of-life doula. She completed her doula training through the University of Vermont, Larner College of Medicine. As a doula, Sherry explores the profound cultural, spiritual, and emotional aspects of this sacred journey as she companions her clients. She hosts death cafés, owns a Facebook group titled End-of-Life Doulas for Progressive Legislation Changes, and volunteers as an EOLONM Board Member and Client Support Team Leader with End of Life Options New Mexico. Supporting New Mexicans, through the EOLONM organization, as they create their own self-directed transition and accompanying them on their journey is a humbling privilege.

Brandon Chuman, PsyD

Originally from Illinois, Dr. Brandon Chuman relocated to Las Vegas in 2021 and currently serves as the Chief of Neuropsychology at Behavioral Health Solutions. His professional journey is both diverse and dynamic. Prior to pursuing psychology, Dr. Chuman worked in graphic design, served as a helicopter flight nurse, and spent four years as an EMT during his undergraduate studies. An injury during his time as an EMT led him to explore psychology, sparking a deep interest in trauma-related fields, including burnout and PTSD. He earned his doctorate from The Chicago School of Professional Psychology in Los Angeles in 2014 and became a licensed psychologist in 2016. Dr. Chuman joined BHS in September 2021, bringing with him a unique blend of clinical expertise and real-world experience.
